2026 Match Play Championship

Event Cost: \$40.00 (plus WSGA handicap fee, green fees & cart fees if applicable)

The event cost includes the prize fee, as well as the Champion's Golf Event & Luncheon that will be scheduled for a weekend date after the Champion has been determined.

All golfers must have a verified WSGA Handicap Index prior to competing in any matches.

The WSGA Handicap fee is -not- included in the event cost but is available for \$35.00 if you wish to register at SHGC. No cost for WSGA handicap for SHGC Members.

Non-members will pay a discounted rate for match green fees & riding cart (25% discount). There are no additional costs for SHGC Members.

Event Information:

Format: 'Match Play' as outlined in the USGA Rules of Golf, with strokes given according to the difference in the competitors' current WSGA Course Handicaps (NOT Indexes) at the time of each match. If you do not know where to find your course handicap, or how to figure out which holes to apply strokes, please ask the golf shop staff prior to beginning your match.

Matches are 18 holes, unless fewer holes are needed to determine the winner. If the match is tied at the end of 18 holes, competitors must continue play in a sudden-death format until a winner is determined. Sudden-death playoff must start on hole #1. Assistance from the golf shop/starter may be necessary to arrange this when the course is busy. Strokes given/received on each hole still apply.

Since WSGA handicaps update daily, it is extremely important that all rounds of golf be posted to the WSGA upon completion. This includes all 9-hole & 18-hole league, match play and casual rounds. All rounds should be posted using hole-by-hole scoring, rather than total score. SHGC Management reserves the right to adjust a competitor's handicap, when necessary, as allowed by USGA/WSGA handicapping rules & guidelines.

Elimination matches (3 per golfer) will be set up by blind draw in a round-robin group format (4 golfers per group) such that your first three opponents will be known. These matches must be completed by June 21, 2026. Golfers must arrange their own match times.

The top 2 golfers from each group will move on to the 'Round of 16' single-elimination bracket. Total # of wins within your respective group will determine who moves on. If there is a tie within the group (for top 2), strength of victories will be used to break ties.

Schedule of Matches:

Elimination rounds (3 per golfer) to be played between May 15 thru June 21, 2026

'Round of 16' matches to be played between June 28 – July 24, 2026

Quarter Final matches to be played between July 25 – August 7, 2026

Semi-Final matches to be played between August 8 – August 21, 2026

Final Match to be played between August 22 – August 31, 2026

All match scorecards must be turned in to the Golf Shop after attested by both golfers.
